

**NOTICE OF PUBLIC HEARING, BUDGET VOTE AND ELECTION
LACKAWANNA CITY SCHOOL DISTRICT
CITY OF LACKAWANNA, COUNTY OF ERIE, NEW YORK**

NOTICE IS HEREBY GIVEN, that a public hearing of the qualified voters of the Lackawanna City School District, Erie County, New York, will be held in the **Martin Road Elementary School Cafeteria, 135 Martin Road**, Lackawanna, New York, in said District on Tuesday, May 6, 2021 at **6:00 P.M.**, prevailing time, for presentation of budget document.

AND FURTHER NOTICE IS HEREBY GIVEN, that said vote and election will be held on **Tuesday, May 18, 2021** between the hours of Noon and 9:00 P.M., prevailing time, at which time the polls will be opened to vote by voting machine upon the following items:

PROPOSITION NO.1- ADOPT 2021-2022 ANNUAL BUDGET

BE IT RESOLVED, that the General Fund Budget for the 2021-2022 fiscal year and the Estimated Tax to be Levied (to be approved as the proposed budget) be submitted as Proposition #1 to the voters on Tuesday, 18th of May, 2021 annual district meeting (election day) for their vote provided by Section 416 of the Education Law; and, in anticipation of such tax obligation of said school district shall be issued.

PROPOSITION No. 2 ELECTION OF FOUR (4) SCHOOL BOARD MEMBERS

The Board of Education in an effort to comply with § 2502 of the Education Law and to bring continuity to the Board, hereby directs that the FOUR (4) trustees with the highest number of votes will be elected to a three-year term beginning July 1, 2021 and ending June 30, 2024.

AND FURTHER NOTICE IS HEREBY GIVEN that a copy of the statement of the amount of money which will be required to fund the Lackawanna City School District's budget for 2021-2022, exclusive of public moneys, may be obtained, effective Thursday, **May 5, 2021** by any resident of the District during business hours 9:00 A.M. to 3:00 P.M., except Saturday, Sunday or holidays, at the Administration Office, 245 South Shore Boulevard, Lackawanna, New York, and at each of the following schoolhouses:

AND FURTHER NOTICE IS HEREBY GIVEN that petitions nominating candidates for the office of member of the Board of Education shall be **RECEIVED AND FILED** by the Clerk of said School District located at the **McKinley School Administration Building**,

Room 107, 245 South Shore Boulevard, Lackawanna, New York, 14218, no later than April 29, 2021, between 9:00 A.M. and 5:00 P.M. Vacancy on the Board of Education is not considered separate, specific offices: candidates run at large. Nominating petitions shall not describe any specific vacancy upon the Board for which the candidate is nominated; must be directed to the Clerk of the District located at the McKinley School Administration Building, Room 107, 245 South Shore Boulevard, Lackawanna, New York 14218; must be signed by at Fifty (50) qualified voters of the Lackawanna City School District; must state the name and residence of each signer, and, must state the name and residence of the candidate.

AND FURTHER NOTICE IS HEREBY GIVEN that applications for absentee ballots will be obtainable during school business hours from the District Clerk located at the McKinley School Administration Building, Room 107, 245 South Shore Boulevard, Lackawanna, New York 14218, beginning April 12, 2021, completed applications must be received by the District Clerk located at the McKinley School Administration Building, Room 107, 245 South Shore Boulevard, Lackawanna, New York 14218, at least seven (7) days (5/12/2021) before the election if the ballot is to be mailed to the voter, or the day before the election, if the ballot is to be delivered personally to the voter. Absentee ballots must be received by the District Clerk located at the McKinley School Administration Building, Room 107, 245 South Shore Boulevard, Lackawanna, New York 14218, no later than 5:00 P.M. prevailing time on May 18, 2021.

A list of persons to whom absentee ballots are issued will be available for inspection to qualified voters of the District in the office of the District Clerk located at the McKinley School Administration Building, Room 107, 245 South Shore Boulevard, Lackawanna, New York 14218, on and after May 14, 2021 between the hours of 9:00 A.M. and 3:00 P.M. on weekdays prior to the day set for the annual election and on May 18, 2021, the day set for the election, and said list will be posted at the polling places at the election. Any qualified voter present in the polling place may object to the voting of the ballot upon appropriate grounds for making his/her challenge and the reasons therefore known to the Inspector of election before the close of the polls.

AND FURTHER NOTICE IS HEREBY GIVEN, that personal registration of voters is required either pursuant to Section 2015 of the Education Law or pursuant to Article 5 of the Election Law. If a voter has heretofore registered pursuant to Section 2015 of the Education Law and has voted at an annual or special District meeting within the last four (4) calendar years, he/she is eligible to vote at this election; if a voter is registered and eligible to vote under Article 5 of the Election Law, he/she is also eligible to vote at this election. All other persons who wish to vote must register.

The Board of Registration will meet for the purpose of registering all qualified voters of the Lackawanna City School District pursuant to Section 2015 of the Education Law at the Board Clerk's Office located at the McKinley School Administration Building, Room 107, 245 South Shore Boulevard, Lackawanna, New York 14218, on May 4, 2021, between the hours of noon and 3:00 P.M., to add any additional names to the Register to be used at the aforesaid election, at which time any person will be entitled to have his or her name placed on such Register, provided that at such meeting of the Board of Registration he or she is known or proven to the satisfaction of said Board of Registration to be then or thereafter entitled to vote at such

election for which the register is prepared. The register so prepared pursuant to Section 2015 of the Education Law will be filed in the Office of the Clerk of the School District at the McKinley School Administration Building, Room 107, 245 South Shore Boulevard, Lackawanna, New York 14218; and will be open for inspection by any qualified voter of the District beginning on Tuesday, May 14, 2021 between the hours of 9:00 a.m. and 3:00 p.m., prevailing time, on weekdays, and each day prior to the day set for the election, except Saturday and Sunday, and at the polling place on the day of the vote.

AND FURTHER NOTICE IS HEREBY GIVEN that pursuant to Section 2015 of the Education Law of the State of New York, the Board of Registration will meet on Tuesday May 5, 2021 between the hours of Noon and 3:00 p.m. prevailing time, at the Office of the Clerk of the School District located at the McKinley School Administration Building, Room 107, 245 South Shore Boulevard, Lackawanna, New York 14218, to prepare the Register of the School District to be used at the election to be held on May 18, 2021, and any special District meetings that may be held after the preparation of said Register, at which time any person will be entitled to have his or her name placed on such Register provided that at such meeting of said Board of Registration he/she is known or proven to the satisfaction of such Board of Registration to be then or thereafter entitled to vote at the school election for which said Register is prepared, or any special District meeting held after Tuesday, May 18, 2021.

AND FURTHER NOTICE IS HEREBY GIVEN, that pursuant to a rule adopted by the Board of Education in accordance with Sections 2008 and 2035 of the Education Law, any referenda or propositions to amend the budget, or otherwise to be submitted for voting at said election, must be filed with the Board of Education at the Office of the Clerk located at the McKinley School Administration Building, Room 107, 245 South Shore Boulevard, Lackawanna, New York 14218, on or before April 23, 2021 by 3:00 P.M., prevailing time; must be typed or printed in the English language; must be directed to the Clerk of the School District; located at McKinley School Administration Building, Room 107, 245 South Shore Boulevard, Lackawanna, New York, signed by at least one hundred (100) qualified voters of the District; and must state the name and residence of each signer. However, the School Board will not entertain any petition to place before the power of the voters to determine, or any proposition which fails to include a specific appropriation where the expenditures of moneys is required by the proposition.
